## IAEA CERTIFICATE OF COMPETENT AUTHORITY SPECIAL FORM RADIOACTIVE MATERIALS

Pipeline and Hazardous Materials Safety Administration CERTIFICATE USA/0352/S, REVISION 9

This certifies that the source described has been demonstrated to meet the regulatory requirements for special form radioactive material as prescribed in the regulations of the International Atomic Energy Agency $^1$  and the United States of America $^2$  for the transport of radioactive material.

- 1. <u>Source Identification</u> Eckert & Ziegler Isotope Products (EZIP) Model AN 241 (formerly 295).
- 2. Source Description Annular welded single encapsulation made of Type 304 or 304L stainless steel. Approximate outer dimensions are 29.97 mm (1.18 in.) in outside diameter, 18.8 mm (0.74 in.) in inside diameter and 2.67 mm (0.105 in.) in thickness. Construction shall be in accordance with attached Isotope Products Laboratories Drawing No. 4004, Sheet 1 of 1.
- 3. <u>Radioactive Contents</u> No more than 5.55 GBq (0.15 Ci) of Americium-241. The Am-241 is in the form of an oxide in a ceramic.
- 4. Management System Activities Records of Management System activities required by Paragraph 306 of the IAEA regulations shall be maintained and made available to the authorized officials for at least three years after the last shipment authorized by this certificate. Consignors in the United States exporting shipments under this certificate shall satisfy the requirements of Subpart H of 10 CFR 71.
- 5. Expiration Date This certificate expires on November 30, 2029. Previous editions which have not reached their expiration date may continue to be used.


