## IAEA CERTIFICATE OF COMPETENT AUTHORITY SPECIAL FORM RADIOACTIVE MATERIALS

Pipeline and Hazardous Materials Safety Administration CERTIFICATE USA/0376/S, REVISION 9

This certifies that the source described has been demonstrated to meet the regulatory requirements for special form radioactive material as prescribed in the regulations of the International Atomic Energy Agency $^1$  and the United States of America $^2$  for the transport of radioactive material.

- 1. Source Identification Gammatron AN-HP Series Model 9.
- 2. Source Description Cylindrical double encapsulation constructed of Type 17-4 stainless steel and seal welded. Approximate outer dimensions are 25.4 mm (1.0 in.) to 38.1 mm (1.5 in.) in diameter and 25.4 mm (1.0 in.) to 101.6 mm (4.0 in.) in length. Construction shall be in accordance with attached Gammatron Drawing No. A-2050.
- 3. <u>Radioactive Contents</u> No more than 0.222 TBq (6.0 Ci) of Americium-241 oxide combined with beryllium, boron, or lithium powder.
- 4. Management System Activities Records of Management System activities required by Paragraph 306 of the IAEA regulations shall be maintained and made available to the authorized officials for at least three years after the last shipment authorized by this certificate. Consignors in the United States exporting shipments under this certificate shall satisfy the requirements of Subpart H of 10 CFR 71.
- 5. Expiration Date This certificate expires on April 1, 2030. Previous editions which have not reached their expiration date may continue to be used.


