This certifies that the source described has been demonstrated to meet the regulatory requirements for special form radioactive material as prescribed in the regulations of the International Atomic Energy Agency 1 and the United States of America 2 for the transport of radioactive material.

- 1. <u>Source Identification</u> QSA Global, Inc. Model X.94 (Manufactured on or after May 21, 1981).
- 2. Source Description Cylindrical single encapsulation made of stainless steel and tungsten inert gas or laser seal welded. The Model X.94 incorporates a copper gasket, a stainless steel insert, and an optional stainless steel spring. Approximate exterior dimensions are 36.2 mm (1.43 in.) in diameter and 8.3 mm (0.33 in.) in length. Minimum wall thickness is 0.2 mm (0.008 in.). Construction shall be in accordance with attached AEA Technology QSA, Inc. Drawing No. RBA11074, Rev. B.
- 3. Radioactive Contents No more than 185.0 GBq (5.0 Ci) of Americium-241. The Am-241 is in the form of an oxide incorporated into a ceramic enamel.
- 4. Management System Activities Records of Management System activities required by Paragraph 306 of the IAEA regulations shall be maintained and made available to the authorized officials for at least three years after the last shipment authorized by this certificate. Consignors in the United States exporting shipments under this certificate shall satisfy the requirements of Subpart H of 10 CFR 71.


