This certifies that the source described has been demonstrated to meet the regulatory requirements for special form radioactive material as prescribed in the regulations of the International Atomic Energy Agency 1 and the United States of America 2 for the transport of radioactive material.

- 1. <u>Source Identification</u> QSA Global, Inc. Model XN162/3 (Manufactured on or after September 27, 1996).
- 2. Source Description Cylindrical double encapsulation with rectangular end piece extension made of stainless steel and tungsten inert gas or laser seal welded. Approximate outer dimensions of the cylindrical portion are 16.7 mm (0.66 in.) in diameter and 12.8 mm (0.5 in.) in length. Approximate outer dimensions of the rectangular end piece extension are 38.0 mm (1.5 in.) in height, 19.0 mm (0.75 in.) in width, and 3.2 mm (0.13 in.) in depth. Minimum wall thickness of the outer encapsulation is 0.04 mm (0.002 in.). Construction shall be in accordance with attached AEA Technology QSA, Inc. Drawing Number RBA62802, Rev. B.
- 3. <u>Radioactive Contents</u> No more than 37.0 GBq (1.0 Ci) of Strontium-90. The Sr-90 is in the form of a ceramic enamel.
- 4. Management System Activities Records of Management System activities required by Paragraph 306 of the IAEA regulations shall be maintained and made available to the authorized officials for at least three years after the last shipment authorized by this certificate. Consignors in the United States exporting shipments under this certificate shall satisfy the requirements of Subpart H of 10 CFR 71.


