This certifies that the source described has been demonstrated to meet the regulatory requirements for special form radioactive material as prescribed in the regulations of the International Atomic Energy Agency¹ and the United States of America² for the transport of radioactive material.

1. Source Identification - QSA Global, Inc. Model X1109 Capsule (Manufactured on or after March 9, 1984).
2. Source Description - Cylindrical single encapsulation made of stainless steel and tungsten inert gas or laser seal welded. Approximate outer dimensions are 5.5 mm (0.22 in.) in diameter and 7.7 mm (0.3 in.) in length. Minimum wall thickness is 0.4 mm (0.016 in.). Construction shall be in accordance with attached AEA Technology QSA, Inc. Drawing No. RBA60201, Rev. A.
3. Radioactive Contents - No more than 11.0 TBq (297.3 Ci) of either Cobalt-60 or Iridium-192. The Co-60 and Ir-192 are in the form of a metal.
4. Management System Activities - Records of Management System activities required by Paragraph 306 of the IAEA regulations shall be maintained and made available to the authorized officials for at least three years after the last shipment authorized by this certificate. Consignors in the United States exporting shipments under this certificate shall satisfy the requirements of Subpart H of 10 CFR 71.
5. Expiration Date - This certificate expires on November 30, 2024. Previous editions which have not reached their expiration date may continue to be used.

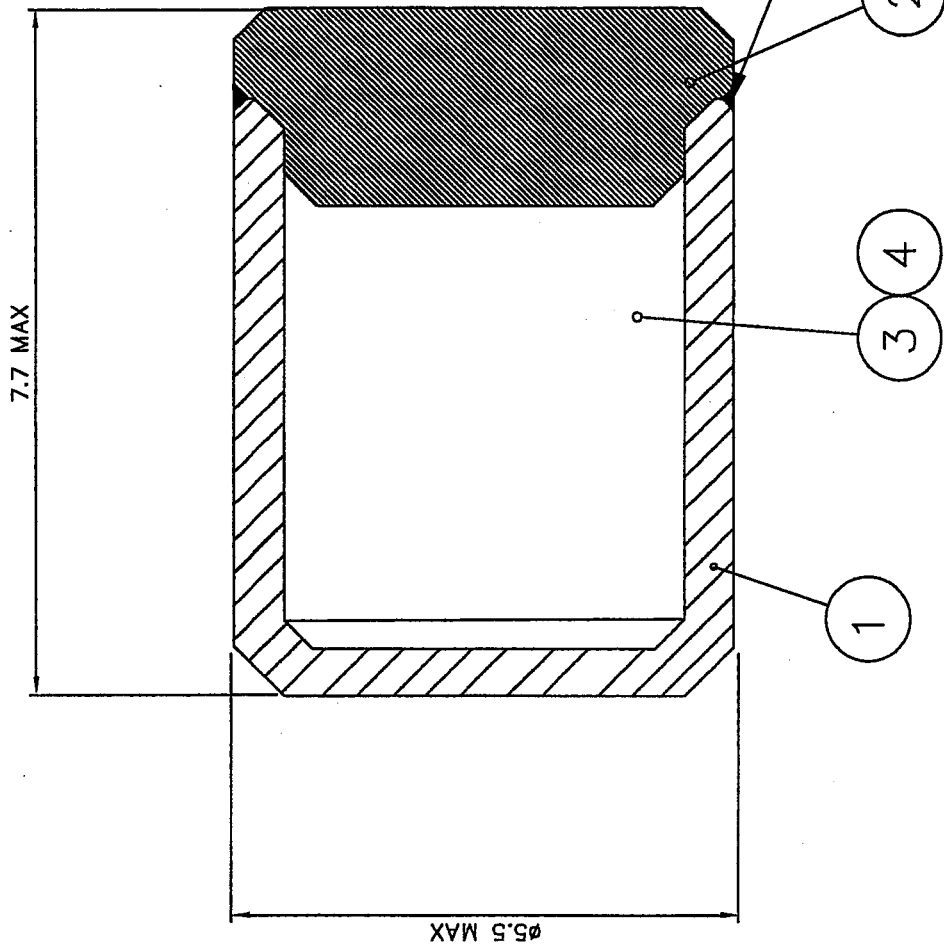
