IAEA CERTIFICATE OF COMPETENT AUTHORITY SPECIAL FORM RADIOACTIVE MATERIALS

This certifies that the source described has been demonstrated to meet the regulatory requirements for special form radioactive material as prescribed in the regulations of the International Atomic Energy Agency 1 and the United States of America 2 for the transport of radioactive material.

- 1. <u>Source Identification</u> Source Production & Equipment Co., Inc. Special Form VSe-5x5.
- 2. Source Description Cylindrical single encapsulation made of vanadium, laser seal welded and either coated with titanium aluminum nitride or plated with nickel. Approximate outer dimensions are 5.03 mm (0.198 in.) in diameter and 5.02 mm (0.198 in.) in length. Construction shall be in accordance with attached Source Production & Equipment Co., Inc., Drawing No. BS1249, Rev. 1.
- 3. <u>Radioactive Contents</u> No more than 5.55 TBq (150 Ci) of Selenium-75. The Se-75 is in a solid metal alloy.
- 4. Management System Activities Records of Management System activities required by Paragraph 306 of the IAEA regulations shall be maintained and made available to the authorized officials for at least three years after the last shipment authorized by this certificate. Consignors in the United States exporting shipments under this certificate shall satisfy the requirements of Subpart H of 10 CFR 71.
- 5. Expiration Date This certificate expires on March 31, 2029. Previous editions which have not reached their expiration date may continue to be used.


